Critical Care position with a Return of Service in the Northern Health Authority

The UBC Critical Care Medicine subspecialty program has 1 subspecialty position in Critical Care Medicine available commencing September 1, 2025. The Re-entry position will be targeted for independent physicians with internal medicine royal college and who are currently providing clinical services in Northeastern BC with an interest in pursuing critical care fellowship training. The position will be targeted for independent practicing physicians (Internal Medicine) who have worked in Northeastern BC communities for at least one (1) year at the time of commencement.

This Re-entry residency position comes with a 3-year Return of Service (ROS) contract with the Ministry of Health. The ROS will be completed in the Northern Health Authority in British Columbia. The participant will be required to sign an ROS contract with the Ministry of Health prior to starting training. Eligibility

- Fully licensed practicing physician registered with a Canadian or a United States regulatory body
- Interested applicants will have completed at least two years of post-graduate training and be in active practice in internal medicine for a minimum of 12 months at the time of commencement
- Applicants must also be a Canadian citizen or permanent resident / landed immigrant
- Transfers from other residency programs will not be permitted
- Physicians currently fulfilling BC Return of Service commitments will not be eligible to apply for re-entry until full completion of their term
- Preference will be given to applicants with a demonstrated interest in working in the designated Health Authority

Application Process

A complete application package will consist of:

1. Official transcripts (for all post-secondary training such as a BA, BSc, Masters, PhD, etc and medical school transcripts)
2. Curriculum Vitae
3. Personal statement discussing professional aspirations and suitability for practice in the designated Health Authorities. The maximum length is one page.
4. Detailed description of residency training to date. This description should include information about relevant training and work experience.
5. Three (3) letters of reference. Letters should include information similar to those items required by the [Canadian Residency Matching Service \(CaRMS\)](#). One letter must be from the current Chief of Staff, Regional Clinical Services Director or Department Head. If the applicant is within 5 years of completion of residency, a letter from the program director or an individual knowledgeable about their residency training overall may also be provided as an option. Additional letters of reference from fellowship trained intensivists are desirable. Provide names, email, addresses & contact information for all references. The position will be offered on a competitive basis by application. Shortlisted candidates will be interviewed. Interviews will take place in the first quarter of 2025.
